

This is the second year at the Favette County Fair that the Triumphs and B.J. reunite. The Triumphs, a nine-piece Houston, Texas-based band has roots that go

back to the early days of rock 'n roll and also launched the career of 5-time Grammy award winner B.J. Thomas. Organized in the fall of 1959, The Triumphs had songs that remain favorites today.

The group disbanded in 1980 for 12 years, then reunited in 1992 packing Riverside Hall of East Bernard with 2,500 fans.

Thomas has sold more than 70 million records and is ranked in Billboard's Top 50 most played artists over the past 50 years.

Bowen, has risen from a collegiate greenhorn to the top of the Texas music and Red Dirt circuit.

Commissioners Vote to Give Themselves a Raise

In a budget workshop and public hearing Monday, Fayette County commissioners voted to give themselves \$1,200 a year pay raises after providing for equivalent raises for county employees earlier in the 2014 budget process. (Employee raises of \$1200 per year or 3 percent, whichever is higher will be at supervisors' discretion.)

After Precinct 2 commissioner Gary Weishuhn raised the issue of raises across the board, County Judge Ed Janecka asked, "I thought we all agreed we were doing OK ... what changed?"

Precinct 3 commissioner James Kubecka noted that "There used to be a big gap between (the salaries of) commissioners and supervisors. There isn't much of a gap any more."

Weishuhn said the situation was similar for other elected officials, pointing out that justices of the peace, "have subordinates earning nearly the same salary. When we say we don't want a raise, that's just us five, what about all those other elected officials."

Auditor Kathy Kleiber noted the raises for 20 elected officials would cost about \$40,000 and "put us in the red" on the 2014 budget.

Janecka said other elected officials could have come to a budget workshop and asked for a raise but none had.

"Well, I want one," Weishuhn said, adding the money could come out of increased revenues from EMS bill-

From Oldenburg, Germany to Oldenburg, Texas

Peter Ostermann, a retiree who lives in Oldenburg, Germany, recently made a six-week trip to America with his wife Petra.

And among their must-see destinations was the tiny Fayette County community of Oldenberg, Texas. Our Oldenburg got its name because it was settlers from Oldenberg Germany, who established the community in the 1880s.

"Finding a little country village gave an impression of a place where people can feel at home," Ostermann said in an interview after he got back to Germany. "A place where they can live a peaceful country life.'

When he planned his coast to coast journey to the United States, Peter said he had the idea to visit the two settlements with the name of his hometown: Oldenburg, MS and Oldenburg, TX.

Before arriving in Oldenburg, Texas, he stopped for a little while in Fayetteville and said it was a very charming little country town. Ostermann said the location of Oldenburg in between towns such as Fayetteville and La Grange is perfect along with the close "bicycle distance" to the Fayette Lake. He remembers Fayetteville having a beautiful center square where the scenery reminded him of the pictures in Mark Twain's novel, Tom Sawyer.

"We enjoyed the beautiful landscape in this area of Texas," Ostermann said.

Ostermann said La Grange has all the necessary shops and supplies allowing him to dream of living there.

They spent just a few hours in Oldenburg and drove around in the area talking to residents.

"It was great for us experiencing how open and hospitable the people living in Oldenburg (and throughout Texas) are and who were ready to tell us about the descendants of the founders of Oldenburg, Texas," Ostermann said.

Other areas in Texas Ostermann and his wife travelled through were Galveston, Houston, Columbus and Fredericksburg.

"From earlier trips in the United States I know that adjoining country roads sometimes are taverns where excel-

It's not as hard as you would think to get to Dubrovnik, Croatia from Round Top, Texas – a non-stop flight from Houston to Frankfurt, a major hub for connections in Europe, and an afternoon flight to Dubrovnik. On that flight will be Round Top Festival Institute Founder and Director James Dick.

He will be making his first trip to Croatia and a premier performance with the Dubrovnik Symphony Orchestra (DSO) on Aug. 27.

The invitation to perform

with the Dubrovnik Symphony was extended by Austrian Conductor, Christoph Campestrini. Campestrini has been a favorite at Festival Hill for the last three Summer Festival seasons. This year he conducted Gustav Mahler's Symphony No. 7 with the Texas Festival Orchestra.

"Christoph supports the idea of education through his many projects and busy performance schedule, so we share a common mission to get young people interested in art and music," stated Mr. Dick during a break in his rehearsal schedule. "His dedication to that goal can be seen in

his tenure at Festival Hill. We look forward to his being on the roster again next summer."

Campestrini and James Dick had been looking for an opportunity to play outside the United States when Maestro Capestrini was tapped to conduct during the 2013 Dubrovnik Summer Festival.

Don't Be Thoughtless And Start A Fire

With Labor Day drawing near, many Texans are planning to spend some time outside, soaking up the last of the summer sun. But Texas A&M Forest Service is urging residents to celebrate carefully as the summer wildfire activity is typically at its highest over the holiday weekend.

The primary areas of concern include the Hill Country, as well as Central and East Texas, where timber and brush are rapidly drying out. But just because you live outside the danger zones doesn't mean you don't have to be careful.

Texas A&M Forest Service Predictive Services Department Head Tom Spencer warned the public to use caution when doing anything outside that could cause a spark.

"Labor Day weekend is the peak of summer fire activity, when everything is at its driest due to the summer heat," Spencer said. "People just need to be aware. Don't let a wildfire ruin the holiday weekend."

MULDOON

It was during Labor Day weekend in 2011 that the most destructive wildfire in state history was recorded. The Bastrop County Complex Fire, one of just 516 wildfires that state and local firefighters responded to that weekend, burned for 37 days, scorching more than 32,000 acres and destroying 1,660 homes.

Keep the following tips in mind to ensure you and your family have a safe Labor Day weekend:

Check with your county judge for current burn bans.

Be aware when grilling on wooden decks or in dry grass. Keep water handy in case of

fire. When transporting portable pits, be sure the fire is extinguished.

Completely extinguish all smoking materials.

Remember your vehicle's exhaust system can ignite a fire when driving through or stopped in dry vegetation. Report all fires immediately to 911.

The Charles Henry Schiege, Sr. Family

Part I of II

Charles Henry Schiege, Sr. was born Carl Johann Rudolph Schiege on June 1, 1815 in Neisse, Silesia, a province of Prussia. His parents were Carl and Johanna Wagner Schiege.

Charles traveled to Texas in 1847 and 1851, returning

to Prussia each time. On July 4, 1855 aboard the ship Franchisca, Schiege and his bride, Carolina Schubert, arrived in Galveston.

Carolina was born on Aug. 6, 1820 in Neisse, Silesia. Carl Johann Rudolph Schiege became a citizen of the United States in 1855 and changed his name to Charles Henry Schiege. Charles and Carolina settled in the Biegel Settlement in Fayette County.

Charles and Carolina had four children, with only one living to adulthood. Their children were: Charles Henry, Jr., born on Sept. 15, 1858; Gustav, lived 7 days; Selma, a twin, born on July 17, 1861, and lived 14 months; Otto, a twin, born on July 17, 1861, and died in 1866.

Charles Henry In the 1860 United States census, Charles Henry Schiege, Schiege, Jr. Sr. was listed as 45 years old, living with his wife, Carolina, and one son, Charles Henry, Jr. His vocation was cabinet maker, chair maker, locksmith and machinist. On September 2, 1861, Charles and Carolina purchased Lot 2 and 3, Block 29 in Round Top from G.C. August Bess for \$100. Later Charles, Sr. purchased one acre from his

neighbor, Conrad Schuddenmagen. Charles H. Schiege, Sr. served in the Confederate Army with Captain Martin Martindale's Company of Unattached Infantry, Fayette County under 22nd Brig. General William Webb, Commander at Fayetteville for six months. Charles is listed on the Confederate Army Veterans Pension Approval List #05275 from Fayette County in Book 1 Comptroller's Index Book.

Charles Henry Schiege, Sr. died on September 30, 1901 at 86 years of age. Carolina Schiege died on June 4, 1893 at 72 years of age. They are both buried in the Florida Chapel Cemetery outside of Round Top.

Their only surviving son, Charles Henry Schiege, Jr. was born in the Biegel Settlement near Fayetteville. By 1860, he was living with his parents on Block 29 adjoining the small village of Round Top. Charles, Jr. attended Pastor Johann Adam Neuthard's School located on White Street in Round Top.

Charles, Jr. married Emma M. Frenzel on April 19, 1885. Emma was born on August 18, 1864 and died on January 26, 1892 without having children. She is buried in the Florida Chapel Cemetery outside of Round Top.

On Nov. 30, 1893, Charles H. Schiege, Jr. married Marie Becker in Round Top. Her parents were Heinrich and Katherine Truede Becker. Marie was born on July 5, 1869 in Round Top. Charles and Marie's 10 children born in Round Top were:

Henry Charles, born Aug. 7, 1894 and died May 30, 1895. He is buried in the Florida Chapel Cemetery.

Charles Adolph William, born June 30, 1896. He married Ida B. Treckmann on Dec. 25, 1920. Charles Adolph died Feb. 9, 1953 and is buried in the Florida Chapel Cemetery.

> Katherine Justine, born on Nov. 26, 1897. She married Oswald Gus Tempel on June 23, 1920. Katherine died on Feb. 21, 1987.

Lina Marie, born on March 10, 1899. She married Kinley Adam Ulrich on June 12, 1920. Lina died on May 15, 1988.

Frederich Charles, born on Nov. 11, 1900. He married Migon Fricke on Jan. 21, 1923. Fred died on Aug. 6, 1972 and is buried with his parents and brothers in the Florida Chapel Cemetery.

Marie Emma, a twin, born on March 26, 1903. She married Rudolph Joseph Legler, who was born on Sept. 19, 1901. Marie died on Jan. 20, 1983, and Rudolph died on

He was mayor of Round Top from 1903 to 1908 and served as the Justice of the Peace, Precinct 3 in Fayette County. He was also a member of the Round Top Volunteer Fire Company for 30 years and was an active member of the Sons of Hermann Lodge No. 151.

The Schiege property on Block 29 in Round Top contained the family private house, a cigar factory, a cigar manager house, a carriage shed, a barn, stables and a large vegetable garden.

Faldyn, Sr.



I was bouncing for joy when I found out Daddy finally had enough money to purchase

an electric washing machine with a wringer on it. We put the washing

in use and shoved it under the stair steps.

Early Monday morning before it was daylight, I would go and light those two big wash kettles that had been already filled with water. Put enough wood under each one so that once I started hauling water to the washing machine on the porch, the other pot of boiling water could be added as I washed.

The two rinse tubs were already in place on a bench and had been filled with a water hose. When the washing machine was full of hot water, all of the white clothes went first.

We always used Tide after we purchased the washing machine.


We put on the washing machine and let it run for about 20 minutes. Then I would stop it and pull the wringer up to the front so that when I put the clothes through it would wring and leave the hot water in the washing machine and let the wet clothes that has just been washed fall into the first rinse tub.

I put another load in the washing machine and turned it on. While it was washing I was rinsing the clothes from the first rinse to the second tub which had blueing in it. This would make the clothes nice and bright.

After I made my round I would take the clothes through the last rinse tub and wring them with the wringer attached to the washing machine.

The last step for the good clothes was to starch what needed to be starched.

I had the first load at the end of the porch ready to go and hang. But before I did, I emptied the washing machine, put in more clothes and then left the second load inside the first rinse water and jumped off the end of the porch and ran to the wash



I did this over and over until I was finished. Often times I would add more hot water so that I could get the work clothes really clean.

After I had everything hung on the wash lines. I was happy because I knew that I was almost finished with the washing part of my chores.

After all was completed I emptied the wash water into the yard. The rinse water always was used on the flower beds. The two rinse tubs were hung on the walls behind the

steps and the washing machine was cleaned inside and out with clorox. When it dried the lid was put on and it was rolled behind the steps and covered up.

With the washing complete, I took out the pillows and laid them in the sun and gave them a good beating with the broom before bringing them back inside.

We always washed the mattress with a clorox solution to make it fresh and clean.

About 3 p.m. I went and got the sheets and pillow cases so I could make each bed. Oh the smell of those sheets! That smell I cannot duplicate with my automatic washing machine. The air was so pure, you would never smell ashes or dust if you hung the wash outside.

I also enjoyed making the beds. Grandma and I would each take a side and we would cover each bed with pull and tug here and there and it was always straight. The fluffed pillows were covered with the pillow cases and in about 30 minutes, all the beds in the house had been made.

The last thing I did was sprinkle the starched clothes with a mist of water so that first thing on Tuesday morning, I could iron all those clothes.

This was a day in the life of a German girl whose day to wash was on Mondays.

La Grange put up plenty of points against Marble Falls in last year's season opener, but turned the ball over three times, which really hurt their chances.


"We moved the ball well against them last year, but they have a new defensive coordinator, so that's another


